## DTC Name Change

Our board is currently in the process of renaming the Denver Teachers Club. We have had several years of input regarding our name, from phone calls and emails, to on-site presentations given by our office manger, Martha Duncan, to our participation in the annual DPS Benefit Fairs. This interaction has made it very evident that our current name is confusing, exclusionary and non-descriptive. We want our name to be clear, inclusive and descriptive as explained below:

### CLEAR

Because of our acronym, DTC, we have always been confused with the DCTA. We are two completely separate organizations. However, due to the confusion, many DPS employees believe this organization does not provide benefits for them. We serve all DPS employees and will make certain this is clear in our new name, which will also provide an acronym that will not be mis-associated with any other organization. We want to be certain our name very **CLEARLY** tells you who we are.

### INCLUSIVE

Our current name implies that we serve a very exclusive group - Teachers. Many of you know that this is not the case, but for those who don't know, we want to bridge the gap. Our Assistance Fund, the place from which you may borrow medical equipment free of charge, serves all Active & Retired employees of the Denver Public Schools, no matter your position. Our Payroll Protection Plan, the coverage available that pays you \$50 a day for absence from work due to illness or injury, is available to all full-time active employees of the Denver Public Schools. We want to be certain our name **INCLUDES** all DPS employees in the group we serve.

### DESCRIPTIVE

Our current name tells you nothing about who we are or what we do. It leads many to believe that we are an exclusive club for Denver teachers. The word "club" seems to make many believe we are a social or civic organization where membership is required and we have duties to fulfill. Nothing could be farther from the truth. We provide our benefits based on filling the needs that many of you have when you or one of your family members is sick or injured. Our Payroll Protection Plan is an insurance that you pay premiums for. The premiums are only \$96 per year (\$8/mth) and you can use the \$50 a day you receive to help with associated medical costs and other bills. Our Assistance Fund provides medical equipment which you can borrow whenever you need it as long as you need it, free of charge, for yourself or any member of your immediate family. This organization is funded through your generous donations, memorials, and bequests and by no other means. These gifts come from Active and Retired employees of the Denver Public School and their family and friends. The Assistance Fund is funded by you and used by you. It is DPS employees supporting each other in a time of need. We want to be certain our name **DESCRIBES** who we serve and how.

The name change will be announced in the next issue of this newsletter to be distributed in early May. We are only changing the name of our umbrella organization, The Denver Teachers' Club, Inc. The subsidiary names, Denver Teachers' Club Voluntary Payroll Protection Plan (Payroll Protection Plan) and The Assistance Fund of the Denver Teachers' Club (Assistance Fund), will remain unchanged.
